# SPECIAL OFFER TO PURCHASE NEW BLUE SUNTAGO ANNUAL CARD FOR SELECTED CURRENT CARDHOLDERS

### Who Is Eligible for the Offer?

This special offer which allows for the purchase of new Suntago Unlimited Blue annual cards (the "New Suntago Card") and a special voucher ("Special Voucher") (the "Offer") is available only to selected current cardholders of Suntago annual cards who have received a special link to the purchase process ("You").

#### What Is the Offer About?

The Offer applies only to the purchase of specific New Suntago Cards and depends on the type of Suntago annual card You currently hold (the "Current Suntago Card"). You may only purchase such New Suntago Card as indicated in the table below:

#### wherein:

- the Blue Relax+ card corresponds in scope to the Relax+ card in the current offer of Suntago Water Park.
- the Blue Relax card corresponds in scope to the Relax card in the current offer of Suntago Water Park,
- the Blue J+ card corresponds in scope to the J+ card in the current offer of Suntago Water Park,
- the Blue J card corresponds in scope to the J card in the current offer of Suntago Water Park, and, in each case, allows for the benefits described in this Offer, in particular in the section 'What Can You Gain by Taking Advantage of the Offer?'

The purchase of a New Suntago Card under the Offer is conditional on the simultaneous purchase of a Special Voucher at a price and value of 10% of thes tandard price of the respective equivalent of the New Suntago Card (e.g., in a package with the Blue Relax+ card, you buy a Special Voucher at a price and value of 10% of the current price of the Relax+ card from the standard offer of the Park).

# When Can You Take Advantage of the Offer?

1. The Offer is valid until the last day of your current contract under which You use the Current Suntago Card (the "**Promotional Period**").

- 2. The New Suntago Card will be automatically activated from the day following the last day of validity of Your Current Suntago Card (commencing a 12-month period of validity for Your new agreement regarding the New Suntago Card).
- 3. Please make sure that You place your order during the Promotional Period because this Offer is only valid during that time. After the end of the Promotional Period, You will not be able to purchase a New Suntago Card on the preferential terms described in the Offer.
- 4. The Offer does not combine with other offers, discounts and promotions offered by the operator of the Suntago Water Park unless otherwise stated in the terms and conditions of individual promotions/offers.

## What Can You Gain by Taking Advantage of the Offer?

If You purchase a New Suntago Card during the Promotional Period:

- a. throughout the validity period of the New Suntago Card (the duration of the new agreement between You and the operator of the Suntago Water Park), You will be entitled to:
  - i. 15% discount on regular prices in shops, restaurants and bars existing at the Suntago Water Park on the day of purchasing the New Suntago Card;
  - ii. 25% discount on regular prices for treatments at Suntago Wellness & SPA.
- b. the price of the New Suntago Card will be 10% lower than current regular price of its equivalent from the standard offer, provided that, together with the purchase of the New Suntago Card at this price, You will also purchase (within the same transaction) a Special Voucher at a price and value of 10% of the standard price of the respective equivalent of the New Suntago Card. You will be able to use the Special Voucher within 12 months from the date of the purchase of the New Suntago Card to purchase products or services offered in the Suntago Water Park e.g. Caban bed, bus ticket etc., except for purchasing entrance tickets. A settlement of the funds allocated on the voucher will take place online, or at the cash desks after your visit to the Suntago Water Park upon presentation of the unique QR code from the voucher.

## Other Issues

- 1. You do not need to provide us with your personal data when You purchase your New Suntago Card. For the preparation of your New Suntago Card, we will use the data (including the photo) that You provided to us in your Customer Account. If your data has changed, please contact us by choosing one of the methods indicated at parkofpoland.com/en/contact.
- 2. If You have ordered a Current Suntago Card for someone else, You can purchase a New Suntago Card for that person or provide them with information about the Offer so they can purchase a New Suntago Card and the Special Voucher on their own under the terms of the Offer as a holder of the Current Suntago Card.
- 3. You have the right to withdraw from the agreement for using the New Suntago Card (including the New Suntago Card and Special Voucher) within the period and according to the rules specified in the Suntago Unlimited Card Regulations (the "Regulations") available at <a href="https://parkofpoland.com/en/terms">https://parkofpoland.com/en/terms</a>.
- 4. If You fully or partially use the Special Voucher (purchased under the Offer) and then you exercise your right to withdraw from the contract on the use of the New Suntago Card in accordance with the terms of the Regulations, in addition to the settlement rules outlined in the Regulations, You will be required to return the amount You have spent by using the Special Voucher (in the first instance we will make a deduction of the funds you spent with the voucher with the amount due to You as a result of the withdrawal).
- 5. Your agreement for the use of the New Suntago Card consists of your order, the Regulations (taking into account changes resulting from this Offer, including the changes indicated in points herein below), the price list in force on the date of placing the order, and this Offer, which changes the provisions of the Regulations to the extent indicated herein. You accept these documents when placing an order for the New Suntago Card.

- 6. Whenever the Regulations refer to the cards: Relax+, Relax, J+, and J, in Your case, it means respectively (depending on the card you possess) the Blue Relax+, Blue Relax, Blue J+, and Blue J cards. At the same time, You are entitled to special privileges as mentioned in this Offer, in particular in the section 'What Can You Gain by Taking Advantage of the Offer?'
- 7. The provisions of points 3.2 3.5, 5.1 5.3, and 6.1 of the Regulations do not apply to your agreement for the use of the New Suntago Card.
- 8. The rules for using the Special Voucher are governed by the Rules for using special vouchers for the Suntago Water Park, which you accepted when placing an order for the New Suntago Card.
